To Parent/Guardian:

Your son/daughter has chosen to participate in an athletic program in the Sumner School District. The Sumner School District will **not** provide transportation in the following situations:

1. Off-campus High School practice sites
2. High school, Varsity and Junior Varsity away contests within the Sumner School District
3. Return trips from away contest sites, as follows:
 - a. High School Frosh/"C" team away contests within the Sumner School District
 - b. Middle School away contests within the Sumner School District
 - c. High School away contests to White River HS and/or Enumclaw HS venues
 - d. Middle School away contests to Orting MS and/or Glacier MS (White River SD) venues

The district will provide **one-way transportation to an away contest site** to all away contests listed in #3 above.

For the situations listed above, parents may provide transportation for their student voluntarily if they choose to participate in the program.

Non-Parental Transportation Permission (only fill out the remaining portion if parents choose to allow non-parental transportation)

If the student elects to participate in any athletics program, then he/she may elect, IF PERMISSION IS GRANTED BY THE PARENT/GUARDIAN, to use non-parental, private transportation. In such cases, the coach will instruct the student who is driving as to the general route to and from the assigned destination; require written assurance from the student/parent that he/she has a valid Washington State driver's license; a current liability insurance policy with minimum limits of \$100,000/\$300,000; and parent's/guardian's permission (see below). Should questions arise, parents/students are urged to talk to the coach.

If your son/daughter will, at any time, be utilizing (driving/riding) non-parental, private transportation, the following must be completed:

In the situations listed above, the Sumner School District assumes no responsibility for the transportation of the student participating in athletics. As the parent/guardian of the above-named student, I/we release Sumner School District from any and all claims, damages or action that may arise out of an accident or injury resulting from the voluntary transportation utilized for athletics. I/We further agree to indemnify and hold harmless the Sumner School District from any and all claims, demands, or actions for damages or injury to person or property from the occurrence of any such accident.

If I/We have checked above that our son/daughter will be driving an automobile; we are assuring the Sumner School District (by evidence of our signature below) that our son/daughter possesses a current and valid Washington State driver's license and we/he/she is insured to the above-mentioned limit.
